Pursuant to the California Cattle Council Law, the following cattle and conditions are exempt from the assessment:

- Calves weighing less than 200 lbs.
- Hides, skins, or the offal of animals.
- Cattle and calves transported for purposes other than sale or harvest and without a change in ownership.
- Cattle and calves harvested for personal use.
- Cattle or calves originating outside the state, **transported solely** to a stockyard or slaughter facility to be sold or slaughtered within 30 calendar days of arrival. (Cattle leaving the plant and returning within 30 days for slaughter are not eligible for the exemption.)
- Cattle or calves sold within 10 days of being purchased where the seller can demonstrate the assessment has been paid within the past 10 days.

Instructions for Submission:

- The California Cattle Council Law requires an assessment of \$1.00 per head on all cattle and calves slaughtered at a California packing facilities, except those expressly listed above.
- **COMPLETE AND RETURN BOTH SIDES OF FORM WITH PAYMENT.**
- All payments should be returned in the form of a check. **DO NOT SEND COIN OR CURRENCY.**
- **THIS REPORT IS TO BE FILED EVEN IF ZERO CATTLE ARE SLAUGHTERED**
- All assessments for the previous month are due by the 15th day of the following month. (e.g., Assessments for the month of November are due December 15th.)
- **ONE COMPLETED COPY OF THIS FORM MUST BE ENCLOSED WITH PAYMENT PER MONTH.**
